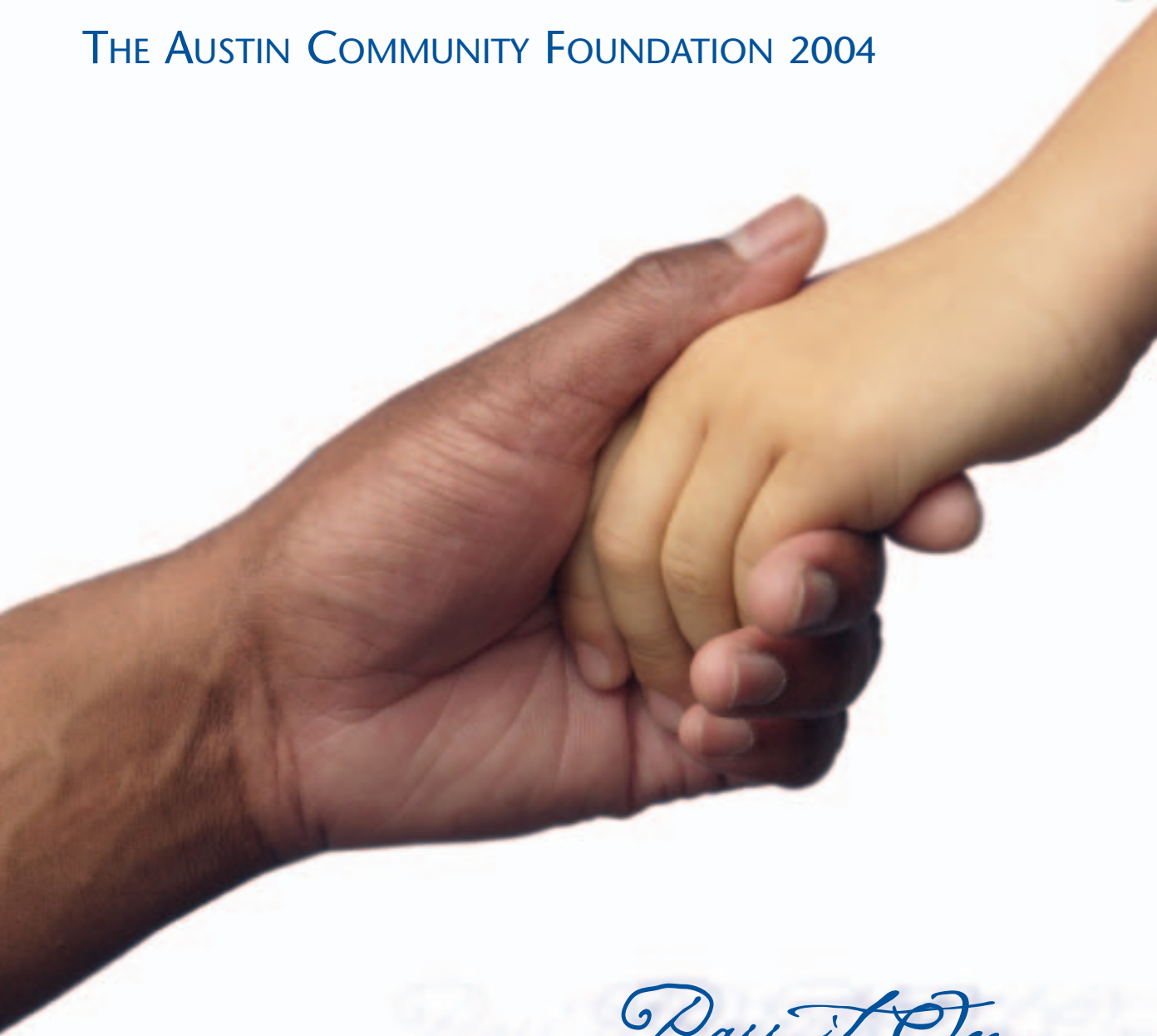

These are just a few of the stories behind all the numbers and lists. And it's these stories that illuminate the true meaning of philanthropy.



It was created to provide a cost-effective and tax-efficient way for members of a community to pool their resources to improve the quality of life for residents in their region. The funds would be invested and benefit their community for perpetuity. Today, that concept is still very much alive and it has been enhanced by the ability of community foundations to work with individuals and families to establish their own charitable funds within the foundation to accomplish their goals. The community foundation can help make “giving back” a family tradition and a way to express one’s charitable values.

The Austin Community Foundation has the flexibility to help individuals, a family, or a company with its charitable giving. We can make it efficient because of the economy of scale of having many funds under one organization, thus there are fewer costs. We also are knowledgeable about our community and can provide information on issues and area non-profit organizations. Our goal is to make giving simple and meaningful for anyone in the Austin area and to improve the lives of those who live here.
